FAC 2023 COVID Protocols at Pinewoods Camp The COVID environment is fluid and continuously evolving. These guidelines may change before and during the camp season.

Updated August 15, 2023

Vaccinations

All campers/staff over 6 months of age must provide proof of vaccination against COVID. This includes either: the original vaccination series* OR a bivalent booster

* Moderna, Pfizer, or AstraZeneca (2 initial shots), or Johnson & Johnson (1 initial shot)

Note: For those traveling from other countries or with medical exemptions, contact FAC by June 16.

Testing Requirements

FAC campers are required to test a total of 3 times (per session*) at Pinewoods, as listed below and should bring their own test kits. A limited number of antigen and NAAT test kits will be available for purchase at arrival and in the Pinewoods camp office.

• test #1. Show proof of a negative test result upon arrival by either: taking a rapid antigen or NAAT test upon arrival

OR

taking a rapid antigen or NAAT test within 3 hours of arrival

- test #2. 24 hours after the start of camp, campers must test again
- test #3. 48 hours after the start of camp, campers will test a final time

* If a camper is attending more thn one session, and does not leave camp between sessions, they are only required to test one additional time on the changeover day.

Note: additional testing may be implemented due to increased COVID-19 transmission levels or an emergence of a more severe variant.

Masking Requirements

• While indoors, and during outdoor gatherings, well-fitting, high-filtration masks (N95, KN95, KF94, or equivalent) are required for the first 24 hours of the session.

• Spaces requiring masking include: Dining Hall (when not actively eating), Kitchen Camphouse Common areas (Pinecones & Hunsdon House), Outdoor group activities: outdoor dining tent or Camphouse porch, Program Provider Center, Bookstore, Dance pavilions

• If all campers/staff test negative before dinner on Friday (Weekend) or Tuesday (FolkDays), the masking requirement will be lifted and masks will become optional.

• Campers/staff may be asked by PCI to wear high-filtration masks whenever engaging in any camper jobs in the kitchen or dining hall, even after the masking requirement has been lifted.

• Weekend session campers/staff staying for FolkDays are not required to remask if they have not left camp and they test negative.

Positive COVID Cases While at Camp

Updated August 15, 2023

Despite the best efforts of FAC and PCI, campers/staff may develop symptoms of, or test positive for, COVID-19 while at camp. In these cases the following steps will be taken:

• Symptomatic individuals will be asked to quarantine in their cabin and self-test. If the test is negative, the individual(s) may be asked to take a NAAT test or go off-site for a third party rapid PCR test. If the NAAT/rapid PCR test is negative they:

- may return to camp and resume regular activities
- should wear a high-filtration mask when interacting with others, both inside and outside, as long as they remain symptomatic.
- should eat outside at least six feet away from other campers.

• Asymptomatic individuals who test positive on a rapid antigen test will be asked to quarantine and retest the next day. If that test is negative, the person may return to regular camp activities.

• Individuals with a positive result will be asked to either:

Return home if they have transportation and are able to safely drive OR If unable to leave, quarantine at camp (PCI will help facilitate this)

• Should a significant number of campers test positive for COVID-19, the PCI Executive Committee will confer with FAC's Executive Director will confer to determine if the current session should be suspended.

• Individuals who test positive at arrival, along with any travel companions who have not worn a highfiltration mask while in the same car, will not be permitted into camp.

Miscellaneous

• By attending a session at Pinewoods this summer, you are agreeing to the 2023 PCI COVID Attestation. Please review the document before arrival.

• PCI strongly encourages campers to take a preliminary rapid antigen test 24 hours before arrival, particularly if you are traveling a long distance.

• In the week prior to arriving at Pinewoods, we kindly ask incoming campers and staff to wear high-filtration masks in indoor public areas and in gatherings with any people who are not in their households.

• FAC will reach out to campers for whom we do not have vaccination details on file.
